The Voluntary Labelling Scheme for Digital Terrestrial Television (“DTT”) Receivers (“the Scheme”) is aimed at providing some guides for consumers shopping for DTT receivers. The Scheme applies to manufacturers and dealers of DTT receivers who have participated in the Scheme on a voluntary basis (collectively referred to as “Suppliers” hereafter).

The register contains models of DTT receivers on which the Suppliers use the Labels. The information contained in the register is provided by the Suppliers and is for reference only.

By granting Suppliers the licence to use the Labels and by publishing the register, no warranty or guarantee, express or implied, is given from the Government of HKSAR, the Communications Authority (“CA”) and the Office of the Communications Authority (“OFCA”) as to the accuracy of the information about the DTT receivers or as to the compliance of the DTT receivers with the relevant standards.

While OFCA may conduct random tests on the DTT receivers, the tests are limited to certain features. For the list of items that may be tested, please refer to OFCA’s website (www.ofca.gov.hk).
